1. Call to order.
2. Meet with engineer on the issues as to engineering study for clean out, improvement of drainage of old system, staging of work, and time frame for any engineering study for District #4.
 - a. The possible examination and costs of installing pumps to move the water to outlets.
 - b. Discuss whether there could be a separation of the surface water from the ground water and operated as a storm water management district with an assessment of costs to deal with the surface water.
 - c. Examination of whether there could potentially be an arrangement worked out with the Town of Bristol on holding the water or pumping the water.
3. Cost estimates for engineering work, scope of engineering work, and discussion with regard to concerns over flooding and the watershed from the housing developments.
 - a. Discussion regarding how those downstream from the District will be affected by clean out work.
 - b. Should there be an engineering study on what can be done. What is the estimated cost for such study?
4. Follow up on what can be been done to prevent the issues caused by the developments.
5. Discussion on unreported laterals hooked into the district.
6. Recommendation from engineer and members of District #4 in attendance as to how to proceed.
7. Decision and or motion by Drainage Board as to how to proceed.
8. Decision on hiring the engineer for a study and the estimated cost thereof.
