RE: Proposal - Engineering Services District 19 Drainage Plans

Based on our meeting, our understanding of the project is to prepare plans and specifications that comply with DATCP Chapter 48.20 requirements for District 19 in Dane County. District 19 is located in the Town of Cross Plains and the Town of Middleton and consists primarily as the upper end of Black Earth Creek. Based on the boundary shown on the Dane County GIS website the ditch consists of approximately 5 miles of main ditch and a 1 mile lateral ditch. The scope of services below summarizes items planned for preparing the District's Plans.

Scope of Services

- Survey ditch in Dane County Coordinate System and vertical datum including:
 - Existing ditch channel cross sections 3 per mile
 - Existing structures (culverts, tile outlet, etc) that are readily visible.
- Hydrology
 - Calculate flows for the ditch base flow and 10yr24hr event to comply with DATCP requirements.
- Hydraulics

Develop HECRAS model to develop water surface profile for plans based on proposed ditch cross section for baseflow and 10yr24hr flows.

Plan set

Plans and specifications will be put together to comply with DATCP 48.20 requirements once the board approves of one of the options. The plan set will include:

- District map
- o Profile
- Cross sections
- Existing structures
- Design report

A design report will explain any assumptions, the design process and include necessary calculations for the design.

Attend hearing

Services will be performed on a Time and Material basis in accordance with the attached Agreement for Professional Services and Fee Schedule. Additional services provided will be performed on a time and material basis or for a fixed fee as agreed upon in advance of the services being provided. Based on this scope and our understanding of the project we estimate a cost \$19,000 to complete these items.
