To Kevin Trost and the Dane County Drainage Board,

I am in Drainage District #27 and received a public hearing notice regarding the district that will occur on August 14. I would like to formally object to the assessment we were given in 2025. There was no warning for the work done nor for the assessment charged to us. In addition, I fail to see how the work that was done would benefit my address given it is for farm drainage and given the large distance between my home and the streams that were worked on. More importantly, it certainly is not fair to be charged this assessment when the drainage board was found to be in violation of state laws in the process of all this. As found by the Department of Agriculture, Trade and Consumer Protection, the drainage board did not seek bids for the work, did not notify the landowners of the public hearing via mail, and did not obtain an engineer's report showing the benefits residents receive from this work. It is my understanding there is no certified engineer's report, no survey, no documentation of benefits to the landowners, and no bids. There is nothing to support that this was done legally and there is nothing to support that I am benefitting from this. Thus, I formally object to the \$250 assessment being asked of us.

I am formally petitioning to be removed from Dane County Drainage District 27 and to be released from the current and any future assessments as my property does not receive any benefits from the drainage district's systems, nor does it receive any benefits from the recent \$40,000 project completed on property owned by Fly Over Acres LLC. Myself and many of my neighbors were actually surprised to find out our properties were in a drainage district when we received the \$250 assessment for this work done on properties owned by Fly Over Acres LLC. I have owned my property since 2017 and according to WI 88.212 I should have received at least two of these notices.

 WI 88.212.1 "Beginning in 2009, and every 3 years thereafter, provide written notice to every person who owns land that is located within the drainage district that such land is in the district. The notice shall also include contact information for every member of the drainage board".

- Annual Reports for Drainage District 27 for all years going back to 2017. WI 88.19 Board to keep records, WI 88.24 Board to file annual report, and ACTP 48.14 Annual inspection.
 - o The last available Annual Report on danecountydrainage.org is from 2021.
 - o The available report for 2019 is the same document submitted for 2017.
- Meeting Minutes from the September 16, 2024 Drainage Board Meeting. The Meeting
 Minutes from the October 8, 2024 meeting state "The August 1, 2024 and September 16,
 2024 meetings were both approved as written" but no available record of the Sept
 meeting. WI 88.19 Board to keep records.
 - The \$40,000 project was proposed, discussed, approved, and a bid completed all in one meeting?
- Any and all reports, surveys, bids, and costs related to the recent \$40,000 project
- Any and all reports or inspections related to benefits to my property from the drainage district.
